1. The Government of Bangladesh has received financing from the International Development Association (IDA) towards the Modern Food Storage Facilities Project (MFSP) and intends to apply part of the proceeds to payments for the consultancy services.
2. The Government of Bangladesh intends to hire Project Management Consultant (PMC). The main objectives are:
 - a. Baseline survey of more than 600 offices of DG Food for intranet & internet connectivity,
 - b. Design connectivity,
 - c. Assess requirement of hardware and software,
 - d. Design software requirement specification for Nationwide Online Food Stock Monitoring System
 - e. Preparation of ICB document for the System Integrator firm
 - f. Supervision and Monitoring of the activities of System Integrator firm etc
3. The Terms of Reference are available in the website of the project (www.mfsp.gov.bd) and DG Food (www.dgfood.gov.bd), which will provide detailed scope of work and required qualifications and experiences.
4. Duration of consultancy: The service is expected to run for 3 years.
